

Premier League Hall of Fame Giveaway

Terms and Conditions

These terms and conditions together with any specific instructions on the Avery Dennison Instagram account @AveryDennisonTS are the competition rules (the “**Rules**”) and apply to the Premier League Hall of Fame Shirt Giveaway (“**Giveaway**”). By participating in the Giveaway, you agree to abide by these Rules.

The Giveaway is organized by Avery Dennison Retail Information Services UK Ltd., a company incorporated under the laws of the United Kingdom whose registered office is at Unit 9-10 Castlebridge Office Village, Kirtley Drive, Nottingham, NG7 1LD, United Kingdom (“**Avery Dennison**”).

The Giveaway commences at 22 April 2022, 9:00 AM CEST and will end at 6 May 2022, 11:59 PM CEST (the “**Entry Period**”).

Avery Dennison may, at its sole discretion, apply, interpret, terminate, alter, limit, suspend or modify the Giveaway, and/or its rules, regulations or benefits at any time, without notice. Any changes will be posted within these terms and conditions. The most recent terms and conditions will always be posted on the Website(s). Any participant who refuses to accept the modifications to the terms and conditions must cease to take part in the Giveaway.

Eligibility

The Giveaway is open globally to any natural person of legal drinking age in their country of residence and older, and who legally resides in their country of residence (the “**Participant(s)**”).

Employees, officers, directors, agents and representatives of Avery Dennison and its Affiliates or close relatives thereto (husband/wife, mother, father, brothers, sisters, sons, daughters or partners living in the same household), parent companies, subsidiaries and affiliates, distributors, dealerships and companies involved in the implementation and execution of the Giveaway are not eligible to enter the Giveaway.

The entry must be filled out in English. In case of multiple entries by a Participant, only the most firstly submitted application will be taken into account by Avery Dennison.

The Giveaway is a promotion, and the eight (8) winners (the “**Winners**”) will be selected at random. The Winners will be announced via email on 8 May 2022 (CEST).

Where entries are being judged on subjective criteria, Avery Dennison reserves the right not to select a Winner, and or to remove or amend selection criteria and or the structure and operation of the Giveaway if entries are not of the requisite standard.

Avery Dennison reserves the right to inform the Winner personally and the Winner and the Participants undertake to keep this information confidential until the official public announcement by Avery Dennison.

Severability and Waiver

Should any provision of these Rules be held invalid or unenforceable for any reason or to any extent, such invalidity or unenforceability shall not in any manner affect or render invalid or unenforceable the remaining provisions of these Rules, and the application of that provision shall be enforced to the extent permitted by law.

Any failure by Avery Dennison or any third party beneficiary to enforce the Rules or any provision thereof shall not waive Avery Dennison's or the applicable third party beneficiary's right to do so.

Governing law and Dispute Resolution

The Giveaway and the Rules will be governed by English law without regard to choice of law provisions and any disputes hereunder will be subject to the jurisdiction of the courts of London, The United Kingdom. Participants accessing the Giveaway outside of The United Kingdom will be responsible for compliance with all applicable local laws.
